
****TERMS AND CONDITIONS OF THIS AGREEMENT ARE ALSO ON FILE AT THE ABOVE ADDRESS****

For and in consideration of the sum of \$N/A, it is hereby agreed that the Lessor shall lease the abovementioned vehicles to Lessee for use in loading and transportation of such property as Lessee may require for the time period specified and under the terms and conditions set forth in the document titled "Terms and Conditions of Equipment Master Lease Agreement," available upon request. Payment of said compensation is due and payable to lessor within 15 days after submission of necessary delivery documents, Lessee identification instruments, and other paperwork concerning trip(s) in the service of Lessee. Such delivery documents and paperwork shall consist of logbooks required by the United States Department of Transportation ("USDOT") and other documents necessary for the authorized carrier to secure payment from the shipper.

REMINDER TO LESSEE: Motor carriers are required to use qualified drivers per the safety regulations in 49 CFR 391.63 and 391.65. Additionally, Section 395.8(j)(2) requires a motor carrier who uses a driver intermittently to obtain from the driver a signed statement giving the total time of duty during the immediately preceding seven (7) days and the time at which the driver was last relieved from duty prior to beginning work for the motor carrier.
