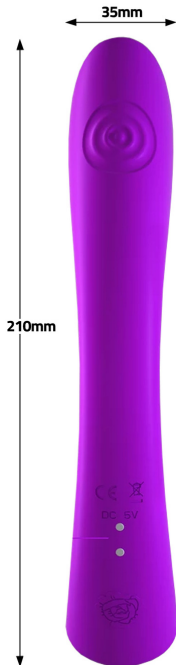

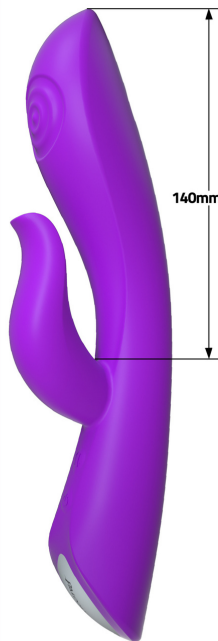

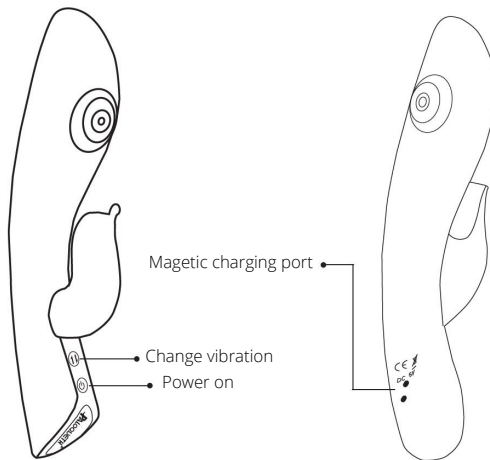
Introduction

User Manual



Charging Mode

1. Attach the magnetic end of the supplied USB cable to the two metal contact points on the back of the device.
2. Plug the USB end into any USB port, such as a PC or wall adapter. The LED light in the button will flash red when the device is charging.
3. Charge the device until the emitted red light stops flashing and remains solid red. The device takes about 3 hours to fully charge.

Note: It is recommended to fully charge the device before first use for maximum experience.

Power on mode

1. Press and hold the power button on the device for 3 seconds to turn on the device.
The red light in the power button will turn on and begin to strike and vibrate, indicating that the vibrator is on.
2. Press the button indicated on the device to cycle through the 7 vibration modes to stimulate the G-spot and clitoris.
3. Press and hold the power button (©) on the device for 3 seconds to turn the device off.
The red lights in the two buttons will turn off and the vibration will stop, indicating that the vibrator has been turned off.

Note: Please lubricate before using the product to get the best experience.

Cleaning and care information

- 1.** Use only a water-based lubricant with silicone-based devices,
Never use silicone-based lubricants, massage oils or hand creams because they damage the silicone in your device. This can trap bacteria and break your toy.
- 2.** Lightly clean the toy with mild soap and water after each use. Use
Never use cleaners containing alcohol, benzine or acetone. They
damage the toy.
- 3.** Wipe with a clean cloth and allow to air dry completely before storing the toy in its box.
- 4.** Storage should be in a cool, dark place to ensure product durability.
- 5.** Never store in direct sunlight or in a warm place, for example, in your car during the summer.
- 6.** Keep out of reach of children and pets.
