

## CONTEST RULES AND REGULATIONS HORSE DRAW

**Calgary Stampeders WIT Platform Official Contest Rules and Regulations**. This contest is sponsored by the Calgary Stampeders – Digital Securities (the "Contest Sponsor"). Contest starts at **two hours before posted kickoff on any game date** and ends **three hours after posted kickoff on any game date** (the "Contest Closing Date")

 ELIGIBILITY (a) This contest is open to all legal residents of Alberta who have reached the age of majority in the province or territory in which they reside Alberta.
Employees, agents, and representatives (and persons with whom they are domiciled and their immediate family members) of the Contest Sponsor, its subsidiaries, affiliates, and its sponsors, advertising and promotional agencies, are not eligible to enter this contest. For purposes of these Official Contest Rules, an "immediate family member" is defined as a parent, sibling, child, or spouse.

- 2. HOW TO ENTER NO PURCHASE NECESSARY To enter you must complete the entry form, subscribe or be a subscriber to the **Stampeders Insider** and participate in the entirety of the WIT platform game offered (Scratch & Win). For the opportunity to win, entry forms must include your name and email address. Limit of three (10) entries per person per household, per device per contest date for all home dates, and five (5) entries per person, per household, per device, per contest date for all away game dates regardless of the method of entry.
- 3. ODDS OF WINNING Odds of winning will depend upon the number of eligible entries received by the Contest Closing Date and available prizes. All entries must be received by the Contest Closing Date in order to qualify. The Contest Sponsor will not be responsible for late, delayed, misdirected, lost, or incomplete entries. By entering the contest, entrants accept and agree to be bound by these Official Contest Rules, and accept the decisions of the Contest Sponsor as final and binding in all respects.
- 4. PRIZING All prizes must be accepted as awarded, are non-refundable, and are not convertible to cash. The Contest Sponsor reserves the right to substitute any of the prizes, or any component thereof, with a prize of equal or greater value. Instant win digital prizes must be redeemed within the contest indicated timeframe. Merchandise, food and beverage and hard good prizes must be picked up by the winner following instructions from the Contest Sponsor. 5. SELECTING WINNERS All prizes are awarded by random upon completion of the WIT game. The Contest Sponsor will not contact winners of digital instant win prizes. Instructions for redemption will be included with prize win.

For games played during **home dates**, selected winners can **ONLY** redeem their prizes if they are in attendance at McMahon Stadium during the game indicated. Select prizes, including the grand prizes, can only be redeemed during the game, at McMahon Stadium.

For games played during **away dates**, selected winners will redeem their prizes as instructed.

The Contest Sponsor shall use commercially reasonable efforts to contact the selected entrants of non-instant prizing including merchandise or other hard good prizes using the contact information set out in each of their entries. In the event that a selected entrant cannot be contacted within five (5) after contest close, the entry of such selected entrant shall be deemed void and the Contest Sponsor shall return prizing without redemption.
