

#### **ABOUT ME**

I enlisted in the U.S. Coast Guard in February of 2008. After almost nine years of active duty service, I transitioned from an active duty career to the Coast Guard Reserves in February of 2015. My last command in the Coast Guard was at the Pacific Tactical Law Enforcement Team, a counter-drug team where I served as a Federal Officer. I deployed internationally in direct support of the Counter Transnational Organized Crime (C.T.O.C.) mission to conduct counter narcotics and maritime interdiction aboard U.S. and foreign military vessels. My team's efforts resulted in twenty-two arrests, as well as the successful interdiction of approximately 4,455 pounds of marijuana and 5,265 kilograms of cocaine, with an estimated street value of \$350,015,000. As a valued member of my team, I was selected toward the end of my tour as one of the units Training Petty Officer's, where I was responsible for the law enforcement training at the unit. After transitioning to the Reserves in 2015, I was hired onto the San Diego Harbor Police Department and attended the 103<sup>rd</sup> Regional Academy at Miramar College. After serving two and a half years with the San Diego Harbor Police Department as a Police Officer, I lateraled to San Diego Sheriff's Department where I currently serve as a Deputy in the North County area.
