

## **HORSE DRAW | CONTEST RULES AND REGULATIONS**

Calgary Stampeders HORSE Draw Official Contest Rules and Regulations. This contest is sponsored by the Calgary Stampeders – Digital Securities (the "Contest Sponsor"). Contest starts at 3:30 p.m. June 7<sup>th</sup>, 2025 and runs from 1.5 hours before the scheduled kick off time for each Stampeders game, both home and away. Contest ends 1 hour after the scheduled kick off time for each Stampeders game, both home and away. Contest closes at the last scheduled regular season game of the 2025 CFL season (the "Contest Closing Date")

- 1. ELIGIBILITY (a) This contest is open to all legal residents of Alberta who have reached the age of majority in the province or territory in which they reside Alberta. Employees, agents, and representatives (and persons with whom they are domiciled and their immediate family members) of the Contest Sponsor, its subsidiaries, affiliates, and its sponsors, advertising and promotional agencies, are not eligible to enter this contest. For purposes of these Official Contest Rules, an "immediate family member" is defined as a parent, sibling, child, or spouse.
- 2. HOW TO ENTER NO PURCHASE NECESSARY To enter you must complete the entry form and subscribe or be a subscriber to the **Stampeders Insider**. For the opportunity to win, entry forms must include your name, full home address, email address, and daytime/evening telephone number where you may be reached. Limit of one (1) entry per person per household per day, regardless of the method of entry.
- 3. ODDS OF WINNING Odds of winning will depend upon the number of eligible entries received by the Contest Closing Date. All entries must be received by the Contest Closing Date in order to qualify. The Contest Sponsor will not be responsible for late, delayed, misdirected, lost, or incomplete entries. By entering the contest, entrants accept and agree to be bound by these Official Contest Rules,

and accept the decisions of the Contest Sponsor as final and binding in all respects.

- 4. PRIZING All prizes must be accepted as awarded, are non-refundable, and are not convertible to cash. The Contest Sponsor reserves the right to substitute any of the prizes, or any component thereof, with a prize of equal or greater value.
  - a) GRAND PRIZE: There are 5 grand prizes available to be won for each home and away game. Home game grand prizes are valued each between \$100 and \$235. Away game grand prizes are valued each between \$60 and \$100. Fans must be present at Mcmahon stadium and have a ticket to the game to be eligible to win the five grand prizes for home games. The home game grand prizes must also be claimed at the Horse Draw redemption booth before the start of the fourth period of the game.
- SECONDARY PRIZING: Secondary prizes consist of discounts to the online CGY Team Store only. For every home and away game there are 25 unique 35% off codes, 10 unique 50% off codes, and an unlimited number of 20% off codes to the online CGY Team Store.
- 5. The grand prize must be accepted as awarded without substitution and is not redeemable for cash. All costs not specifically included in this prize description, including, but not limited to, transportation, parking, food and beverage costs, and applicable taxes, will be the responsibility of the winner.
- 6. Before being declared a winner, each selected entrant must first correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited mathematical skill-testing question on the same day and within a reasonable time as indicated by Contest Sponsor making the prize notification information available to the potential winner.

Each selected entrant will also be required to sign a Declaration and Release Form (the "Release Form") confirming compliance with these Official Contest Rules, acceptance of the respective prize as awarded without substitution, and releasing the Contest Sponsor, its affiliated and related companies, sponsors, advertising and promotional agencies, and their respective shareholders, directors, officers, employees, agents, dealers, representatives, successors, and assigns from any liability in connection with the prizes, including (if applicable) attendance at and any recreational activities undertaken as a result of participation in this contest.

The process noted above will be repeated until a prize winner is declared or there are no more eligible entries, whichever comes first.
