Members voted on Tuesday, March 25 at the Special Called Meeting for Delegates for the General Convention and on various amendments to the Local 1243 Bylaws.

Local 1243 membership voted for Chris Smith & Will Wood for the $43^{\rm rd}$ General Convention Delegates in August.

The Local members also voted to approve all suggested amendments to the Local 1243 Bylaws. Members will be notified once the Bylaws are approved with the Western States Regional Council of Carpenters Bylaws Committee and moved to be approved at the Western District.

A MINIMUM OF ONE IN FIVE CONTRACTORS COMMIT FEDERAL TAX FRAUD

Why are so many construction contractors committing tax fraud? They do it to steal jobs from tax-paying businesses and their employees.

Corrupt contractors pay workers off the books, or, less often, as independent contractors when they clearly shouldn't. That allows them to evade state, local, and federal taxes, so they can illegally lower their labor costs to underbid law-abiding competitors.

IT'S INTENTIONAL

Frequently, corrupt contractors use law-breaking subcontractors and labor brokers to shield themselves from accountability.

IT'S NOT SMALL: IT'S \$10 BILLION

Construction industry tax fraud robs our state and federal governments out of \$10 billion a year. No job site is immune. No state is immune. Here are the estimated annual losses:

CUPP is an opportunity for members to earn points, while volunteering their time at various Local or Council events. CUPP issues stipend checks of \$250.00 every January and July to all members who accumulate a minimum of 6 hours during the previous 6month period. Members can set up direct deposit for CUPP stipend check by entering your information directly on MemberXG.

Alaska Unemployment Tax

Members that have worked for more than 1 employer are encouraged to complete an Employee Application for Refund with the State of Alaska at this link <u>EMPLOYEE</u> <u>APPLICATION FOR REFUND</u>. If the state finds that you had withholding in excess of the limits you could be entitled to a refund.
