

CONTEST RULES AND REGULATIONS

Calgary Stampeders Stampede Bowl VIP Experience Official Contest Rules and Regulations. This contest is sponsored by the Calgary Stampeders – Digital Securities (the "Contest Sponsor"). Contest starts at 12:00 a.m. MDT on May 13, 2025 and ends at 11:59PM p.m. MDT on June 25, 2025 (the "Contest Closing Date")

- 1. ELIGIBILITY (a) This contest is open to all legal residents of Alberta who have reached the age of majority in Alberta. Employees, agents, and representatives (and persons with whom they are domiciled and their immediate family members) of the Contest Sponsor, its subsidiaries, affiliates, and its sponsors, advertising and promotional agencies, are not eligible to enter this contest. For purposes of these Official Contest Rules, an "immediate family member" is defined as a parent, sibling, child, or spouse.

In the event that a selected entrant cannot be contacted within five (5) days after contest close, the entry of such selected entrant shall be deemed void and the Contest Sponsor will make a reasonable effort to contact a new selected winner.
