## RESIDENCY PROGRAM STRUCTURE

Mount Carmel Grove City Hospital Residency Program will be a 52-week, rotation-based experience. There are eight (8) one-month required core rotation experiences. Residents will have 12 weeks of elective opportunities. Residents will also have required longitudinal rotation experiences that will last between 3 and 12 months. Residents may elect (if available) to participate in elective longitudinal rotation experiences that will last between 6 and 12 months.
