A relief effort for hospitality workers displaced during the COVID-19 pandemic and Black, Out and Proud, an organization that advocates, inspires, and educates the Columbus Black LGBTQ+ community.

In this capacity, Dr. Hunley-Jenkins team was selected to deliver Individuals with Disabilities Education Act (IDEA) compliance and professional development training to 200+ Columbus City School teachers; established the Equity Now Coalition and the Boys & Young Men of Color Collective (BYMOCC); and led the outreach and engagement efforts for the Columbus Coalition to End Tobacco Targeting, resulting in City Council's unanimous passage of legislation to end the sale of flavored tobacco products, including menthol, in December 2022.
