While this Guide is a tool to answer most of your questions, full details of the plans are contained in the Summary Plan Descriptions (SPDs), which govern each plan's operation. Whenever an interpretation of a plan benefit is necessary, the actual plan documents will be used.

Eligibility and Enrollment

Worldwide Flight Services' benefits are designed to support your unique needs.

Eligibility

If you are an employee of Worldwide Flight Services working at least 20 hours per week, you are eligible to participate in the WFS Employee Extras benefits. Employees working less than 20 hours per week will be eligible for discounts only.

Coverage Dates

Your coverage will be effective on the first of the month following 30 days after you enroll.

Dependents

Dependents eligible for coverage include:

- Your legal spouse, if they are not offered coverage elsewhere.
- Children up to age 26 (includes birth children, stepchildren, legally adopted children, children placed for adoption, and children for whom you or your spouse have legal guardianship).
- Dependent children 26 or more years old, unmarried, and primarily supported by you and incapable of self-sustaining employment by reason of mental or physical disability which arose while the child was covered as a dependent under this plan (periodic certification may be required).

Verification of dependent eligibility is required upon enrollment.

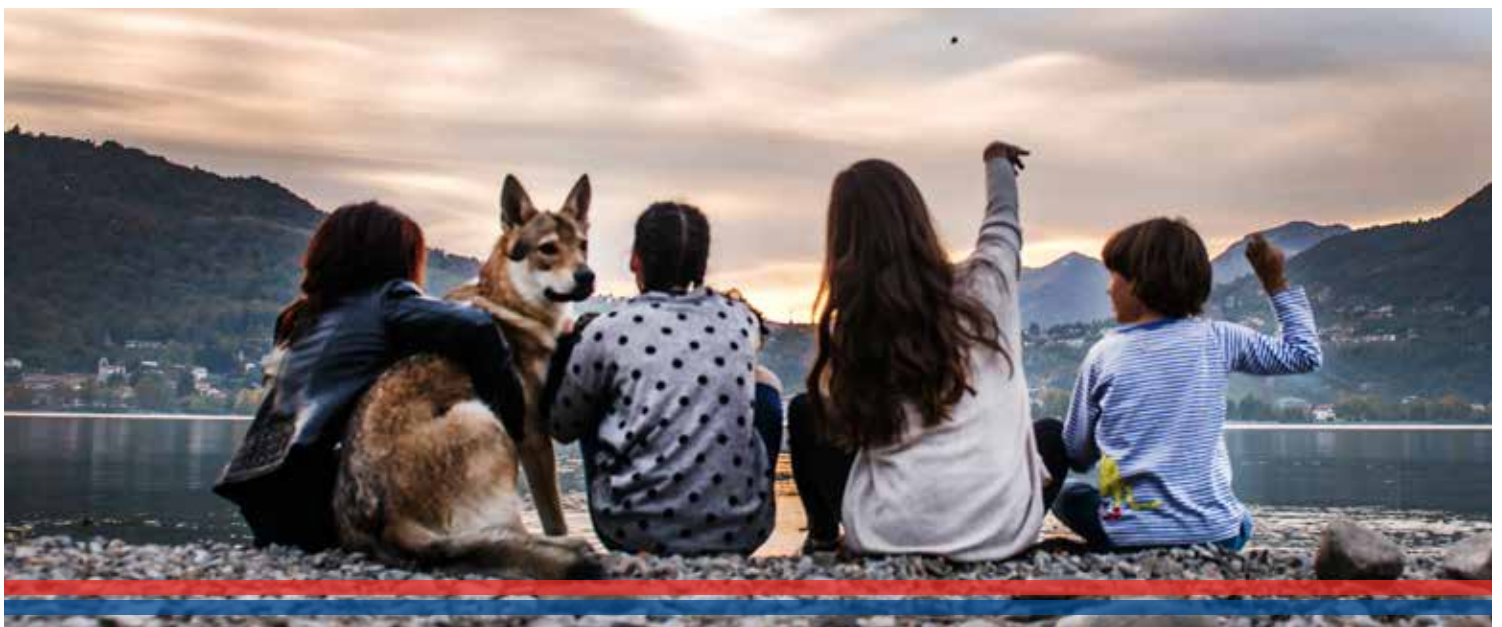
