## ASSE 6005- Generalist/Design

Prerequisite: No previous experience required.  
Generalist certification is provided for medical gas supervisors, architects, engineers, Government officials, administrators, project managers, estimators, or anyone else who has an interest in the proper design, installation, use, and maintenance of medical gas and vacuum systems at health care facilities, dental offices and nursing homes.

## **ASSE 6010- Installer**

Prerequisite: Applicant **MUST** have a minimum of four years prior experience in the field of plumbing systems installation or mechanical systems.

## **ASSE 6020- Inspector**

Prerequisite: Applicant **MUST** be employed or contracted by a health center or government entity as a plumbing or mechanical systems inspector, or be a person regularly involved in the design, inspection, or verification of medical gases, or be an ASSE6010 Installer. All these requirements require a minimum experience of 2 years, in any combination.

## **ASSE 6040- Maintenance**

Prerequisite: Applicant **MUST** be employed or contracted by a health center and / or must have a minimum of one year of documented practical experience in maintaining medical gas systems.
