

## CONTEST RULES AND REGULATIONS

**FlexClub Survey Contest Official Contest Rules and Regulations.** This contest is sponsored by FlexClub, a business unit operated by Calgary Sports & Entertainment Corporation (the "**Contest Sponsor**"). Contest starts at 12:01 a.m. **May 7<sup>th</sup>, 2025** and ends at 11:59PM p.m. MST on **May 25<sup>th</sup>, 2025** (the "**Contest Closing Date**")

- ELIGIBILITY (a) This contest is open to all legal residents of Alberta who have reached the age of majority in the province or territory in which they reside Alberta. Employees, agents, and representatives (and persons with whom they are domiciled and their immediate family members) of the Contest Sponsor, its subsidiaries, affiliates, and its sponsors, advertising and promotional agencies, are not eligible to enter this contest. For purposes of these Official Contest Rules, an "immediate family member" is defined as a parent, sibling, child, or spouse.
- 2. HOW TO ENTER NO PURCHASE NECESSARY To enter you must complete the survey for the opportunity to win. Entry forms must include your name, email address, and daytime/evening telephone number where you may be reached. Limit of one (1) entry per person, regardless of the method of entry.

All entries must be received by the Contest Closing Date in order to qualify. The Contest Sponsor will not be responsible for late, delayed, misdirected, lost, or incomplete entries. 5. SELECTING WINNERS A random draw for the grand prize will be conducted at or about 1 pm MST on **May 26<sup>th</sup>, 2025** by Contest Sponsor from all eligible entries received.

The Contest Sponsor shall use commercially reasonable efforts to contact the selected entrants using the contact information set out in each of their entries. In the event that a selected entrant cannot be contacted within one (1) day, or such other reasonable longer timeframe as selected by Contest Sponsor, in its sole discretion, of the random draw, the entry of such selected entrant shall be deemed void and the Contest Sponsor shall draw another entry at random for the remaining eligible entries. The process noted above will be repeated until a contact is made with a selected entrant or there are no more eligible entries, whichever comes first.
