

CONTEST RULES AND REGULATIONS: SPIN TO WIN

Calgary RoughnecksTradable Bits Platform Official Contest Rules and Regulations. This contest is sponsored by the Calgary Roughnecks – Digital Securities (the "Contest Sponsor"). Contest starts at **12:01 a.m. January 13, 2025** and ends at **11:59PM p.m. MST on January 19, 2025** (the "Contest Closing Date")

- ELIGIBILITY (a) This contest is open to all legal residents of Alberta who have reached the age of majority in the province or territory in which they reside Alberta. Employees, agents, and representatives (and persons with whom they are domiciled and their immediate family members) of the Contest Sponsor, its subsidiaries, affiliates, and its sponsors, advertising and promotional agencies, are not eligible to enter this contest. For purposes of these Official Contest Rules, an "immediate family member" is defined as a parent, sibling, child, or spouse.
