



CONTEST RULES AND REGULATIONS

Calgary Stampede BLITZ PICKS Official Contest Rules and Regulations. This contest is sponsored by the Calgary Stampede – Digital Securities (the “Contest Sponsor”).

Contest starts at **12:01 a.m. June 4, 2024** and ends at **11:59PM p.m. MST on Oct 25, 2024** (the “Contest Closing Date”)

1. **ELIGIBILITY** (a) This contest is open to all legal residents of Alberta who have reached the age of majority in the province or territory in which they reside Alberta. Employees, agents, and representatives (and persons with whom they are domiciled and their immediate family members) of the Contest Sponsor, its subsidiaries, affiliates, and its sponsors, advertising and promotional agencies, are not eligible to enter this contest. For purposes of these Official Contest Rules, an “immediate family member” is defined as a parent, sibling, child, or spouse.
2. **HOW TO ENTER NO PURCHASE NECESSARY** To enter you must complete the entry form, subscribe or be a subscriber to the **Stampede Insider** and participate in the entirety of the BLITZ PICK game offered. For the opportunity to win, entry forms must include your name and email address. Limit of one (1) entry per person per household per contest date, regardless of the method of entry.
3. **ODDS OF WINNING** Odds of winning will depend upon the number of eligible entries received by the Contest Closing Date and available prizes. All entries must be received by the Contest Closing Date in order to qualify. The Contest Sponsor will not be responsible for late, delayed, misdirected, lost, or incomplete entries. By entering the contest, entrants accept and agree to be bound by these Official Contest Rules, and accept the decisions of the Contest Sponsor as final and binding in all respects.
4. **PRIZING** All prizes must be accepted as awarded, are non-refundable, and are not convertible to cash. The Contest Sponsor reserves the right to substitute any of the prizes, or any component thereof, with a prize of equal or greater value. I
 - a) **WEEKLY PRIZE** There is eighteen (18) weekly prizes available to be won consisting of **one (1) Stampede licensed merchandise item valued between \$25 - \$50 per week**
The weekly prize must be accepted as awarded without substitution and is not redeemable for cash. All costs not specifically included in this prize description, including, but not limited to, transportation,

parking, food and beverage costs, and applicable taxes, will be the responsibility of the winner.

- b) **GRAND PRIZE** There is one (1) grand prize available to be won consisting of **one (1) cash prize of \$1,000**. The grand prize must be accepted as awarded without substitution. All costs not specifically included in this prize description, including, but not limited to, transportation, parking, food and beverage costs, and applicable taxes, will be the responsibility of the winner.

- 5. **SELECTING WINNERS** Weekly prizes are awarded to the player with the most accumulated points based on answers to the game questions out of all participating players in one inclusive week. In the event of two or more players have the same accumulated points total then a winner will be selected by random.

A seasonal Grand prize will be awarded to the player with the most accumulated points based on answers to the game questions out of all participating players in all-inclusive weeks during the entirety of the contest period. In the event of two or more players have the same accumulated points total then a winner will be selected by random.
