



## CONTEST RULES AND REGULATIONS: SPIN TO WIN

### **Calgary Roughnecks Tradable Bits Platform Official Contest Rules and Regulations.**

This contest is sponsored by the Calgary Roughnecks – Digital Securities (the “Contest Sponsor”). Contest starts at **12:01 a.m. March 11, 2025** and ends at **11:59PM p.m. MST on March 12, 2025** (the “Contest Closing Date”)

1. **ELIGIBILITY** (a) This contest is open to all legal residents of Alberta who have reached the age of majority in the province or territory in which they reside Alberta. Employees, agents, and representatives (and persons with whom they are domiciled and their immediate family members) of the Contest Sponsor, its subsidiaries, affiliates, and its sponsors, advertising and promotional agencies, are not eligible to enter this contest. For purposes of these Official Contest Rules, an “immediate family member” is defined as a parent, sibling, child, or spouse.
2. **HOW TO ENTER NO PURCHASE NECESSARY** To enter you must complete the entry form, subscribe or be a subscriber to the **Roughnecks Insider** and participate in the entirety of the Tradable Bits platform game offered (Spin to Win: Roughnecks Spin to Win). By entering the contest, entrants accept and agree to be bound by these Official Contest Rules, and accept the decisions of the Contest Sponsor as final and binding in all respects.
4. **PRIZING** All prizes must be accepted as awarded, are non-refundable, and are not convertible to cash. The Contest Sponsor reserves the right to substitute any of the prizes, or any component thereof, with a prize of equal or greater value.

In the event that a selected entrant cannot be contacted within five (5) days after contest close, the entry of such selected entrant shall be deemed void and the Contest Sponsor shall return prize without redemption.
