

Apple Air Heating & Cooling LLC. – Official Rules

The Apple Air Heating & Cooling LLC. Giveaway (the “**Giveaway**”) is intended for legal residents who own homes within the Long Island service areas of Apple Air Heating & Cooling LLC. (the “**Service Area**”) and shall only be construed and evaluated according to applicable federal law and New York state law.
